1. The Lessee will at the Lessee's expense keep the cat in good health and duly and properly feed and will pay as and when required all stud fees, show fees and vet fees
2. The Lessee **will not** desex or permit said cat to be desexed during the term of the Lease without the prior written permission of the Lessor
3. All kittens resulting from matings occurring with said cat leased after the date of commencement will, subject to the Rules of Council, will be registered in the Prefix of the Lessee
4. The parties hereto may mutually agree to terminate this Lease at any time in writing, signed by both parties and properly witnessed
5. If, after the termination or expiry of the Lease, the Lessor and Lessee desire to renew the term hereof, then a further Lease Application Form must be completed and lodged with CatsWA
6. All Lease Applications **MUST** be signed by both parties and witnessed
7. If the Lessee exhibits said cat during the term hereof, the same will be exhibited in the Lessee's name, and if any challenge certificates are won by the Lessee, they will be delivered to the Lessor together with said cat at the expiration of the term of the Lease
8. The Lessor may at any time during the term hereof without the consent of the Lessee, transfer the Lessor's right of titles and interest in said cat but subject to the terms of the Lease
9. At the expiration of the term hereof, said cat must be forthwith returned to the Lessor
10. The Lessee will duly and punctually perform and obey all these Terms and Conditions, the Constitution and Rules of the Council, and in particular Rule 9 of the Breeders Code of Ethics
11. In addition to the foregoing provision, the attached terms shall apply to the extent that the same are not inconsistent therewith.
